The Board of Education of Kaneland Community Unit School District No. 302 met in Regular Session at the Milnamow Administrative Center, Kaneland High School, on Tuesday, June 1, 2010 at 5:02 p.m.

4. Dr. Fuchs reported that the District will only receive one-half of the grant for the Fox Valley Career Center Fire Science Program (\$50,000).
5. The Assistant Principal at John Stewart/Blackberry Creek Elementary School will be posted.
